- (4) To encourage a proactive holistic approach, focused on sustainable long-term solutions using local resources and building regional resilience.

- **Junior** - Any person under the age of 15 years who supports the purposes of the Association and agrees to comply with the rules of the Association is eligible for junior membership. Junior members are not entitled to vote at general meetings but have all the other rights of members.
