Membership:

Associate Member (Junior) - Any person under the age of 15 years who supports the purposes of the Association and agrees to comply with the rules of the Association is eligible for associate membership. Associate members are not entitled to vote at general meetings.

Renewing membership of the Association: Complete the form at the reverse of this sheet to update your data record. Pass it to the Treasurer with the annual fee.

Annual fees: Member \$20.00, and Junior \$10. The annual fee for the financial year are payable by 30 September each year.

The Financial Year of the Association is each period of 12 months ending on 30 June.

General Meetings: Annual General meetings of the Association will be held within 5 months after the end of each financial year. General meetings of the Association are held from time to time.

Committee Meetings: are held on the 4th Thursday of each month and as required.
